## **POLICY:** **Process to Elect A Junior Representative on the Board of Directors**

BC Cattlemen's Association *(Adopted by the Board on December 14, 2023)*

### **Role**

---

- The BCCA Junior Representative is a non-voting member of the board, and is elected by the board of directors. a
- The Junior Representative will attend meetings of the Board of Directors and participate in discussions.

### **Eligibility**

---

- The Junior Representative must be between the ages of 19 - 30 years
- The Junior Representative must be a member in good standing of the Association.
- The Junior Representative must reside in the zone they represent.
- To be eligible, a nomination form along with a letter outlining your experience and interest in the position must be submitted to the BCCA office by May 1<sup>st</sup>.

### **Term**

---

- The Youth Representative is a one-year term, starting at the annual general meeting.
- BCCA will establish a Youth Representative starting in 2024 with Zone 1 Peace, and rotate annually through the zones as follows:
  - Zone 1 Peace youth representative (term 2024-2025)
  - Zone 2 Central youth representative (term 2025-2026)
  - Zone 3 Skeena youth representative (term 2026-2027)
  - Zone 4 Cariboo youth representative (term 2027-2028)
  - Zone 5 Thompson youth representative (term 2028-2029)
  - Zone 6 Okanagan youth representative (term 2029-2030)
  - Zone 7 Kootenay youth representative (term 2030-2031)
  - Zone 8 Island youth representative (term 2031-2032)
- If elected during a year that the AGM is presented in ZOOM format, the Junior Representative has the option to attend the following year in-person AGM at the expense of BCCA as an outgoing Junior Representative

### **Process**

---

- The BCCA Board of Directors will annually review nominations and elect one youth representative.
- If the Youth Representative is unable to finish the term, the Board may at their discretion, appoint a new Junior Representative for the remainder of the term.
- If no nominations from the zone are received the position, the Board may invite a past Junior Representative to fill the position for the term.
- The BCCA Youth Representative is also eligible to serve as the provincial Canadian Youth Cattle Council (YCC) representative on behalf of the BC Cattlemen's Association.
